

You want your vote to count in every elections and the voters in California are about to see a drama unfold as a recount start on July 11, for state controller.


Fresno Republican Mayor Ashley Swarengin, received the most votes and her name will appear on our November ballots.

Democrat Betty Yee, a member of the state Board of Equalization came in at second placed. Only the top two vote getters will be on the November general election ballot.

Former Assembly Speaker John Perez came up short by just 481 votes out of more than 4 million votes cast in the June Primary election. That's a difference of one hundredth of one percent.

The margin between Yee and Perez is so small that both campaigns are fighting over every single vote.



several years involving a pattern of increasing costs, modest discretionary revenue growth, the imposition of new mandates, and targeted funding increases, as well as reductions from the state and federal governments.

While recognizing those above-mentioned obstacles, I am pleased to report that the adopted balanced budget generally maintains existing service levels; however, a number of challenges remain. For example, correctional realignment imposed by the State of California continues to vex local authorities as state funding proves inadequate for this experiment of sending supposed low-level offenders to local jail rather than state prison. The Sheriff's and Probation Departments continue to work hard on this shift of

responsibility.

While we are expecting some revenue growth, the economic recovery is not expanding at a rapid pace that we all had hoped. As a result, the Board remains determined to see taxpayers funds are spent efficiently and prudently just like families are doing with their individual household finances during these challenging economic times.

For resident's district 3 of the unincorporated area who rely upon Sacramento County for municipal services that impact our day-to-day living, the Board of Supervisors has taken a number of actions to improve our quality of life.


