

## WELCOME ELIZABETH

Elizabeth is a fighter and a problem solver. She was "drafted" into a second career as an advocate for developmentally disabled children after her son, Alex, was diagnosed with autism. She is a former executive with Autism Speaks, one of the nation's largest non-profit organizations.

At Autism Speaks, Elizabeth coordinated advocacy for federal legislation addressing autism, including the Advancement in Pediatric Autism Research Act, the lead title of the Children's Health Act of 2000, and the Combating Autism Act of 2006 which authorized nearly \$1 billion over 5 years to combat autism through research, screening, early detection and early intervention.

A vital element of this accomplishment, Elizabeth led the charge to ensure transparency and accountability on how the National Institutes of Health (NIH) would spend autism research dollars. For the first time at the NIH, her efforts produced a portfolio analysis of autism spending that would have to withstand public scrutiny - a policy Elizabeth believes should apply throughout the entire government. Elizabeth launched a multi-state campaign to secure insurance coverage for autism-related services. Thirty states have enacted autism insurance reform laws, saving participating states millions in taxpayer funds that would otherwise have been directed to state health care and special education services. This groundbreaking legislation, aimed at ending marketplace discrimination against individuals with autism, passed into law in California on October 9, 2011.

Elizabeth has worked extensively advocating on behalf of military families at the Department of Defense for autism related medical services in TRICARE, the health care program for active duty service members and retirees.

Elizabeth and her husband of 27 years, Craig, reside in Fair Oaks with their two daughters and 21-year-old son, Alex, who has autism spectrum disorder.

## THE 150th ANNIVERSARY OF THE GETTYSBURG ADDRESS ON NOVEMBER 19



The Gettysburg National Cemetery was dedicated by President Abraham Lincoln a brief four months after the Battle. Lincoln's speech lasted only two minutes, but it went into history as the immortal Gettysburg Address.

"Four score and seven years ago, our fathers brought forth on this continent a new nation: conceived in liberty, and dedicated to the proposition that all men are created equal.

Now we are engaged in a great civil war. . .testing whether that nation, or any nation so conceived and so dedicated. . . can long endure. We are met on a great battlefield of that war.

We have come to dedicate a portion of that field as a final resting place for those who here gave their lives that that nation might live. It is altogether fitting and proper that we should do this.

But, in a larger sense, we cannot dedicate. . .we cannot consecrate. . . we cannot hallow this ground. The brave men, living and dead, who struggled here have consecrated it, far above our poor power to add or detract. The world will little note,

nor long remember, what we say here, but it can never forget what they did here. It is for us the living, rather, to be dedicated here to the unfinished work which they who fought here have thus far so nobly advanced.

It is rather for us to be here dedicated to the great task remaining before us. . .that from these honored dead we take increased devotion to that cause for which they gave the last full measure of devotion. . . that we here highly resolve that these dead shall not have died in vain. . . that this nation, under God, shall have a new birth of freedom. . . and that government of the people. . .by the people. . .for the people. . . shall not perish from the earth. "

### CRIME AND AB 109

Violent crime in the United States increased by 15 percent last year and property crime was up by 12 percent.

Part of the reason may be because desperate people do desperate things and as economic conditions continue to deteriorate we see an increase in crime.

My first job was working at a bank so I was used to seeing and working with armed guards, but not at my local super market. So the first time I saw security personal at super markets I was surprised. Now it's just something I take for granted. And now I would not be surprised to see armed guards on food trucks.

In neighboring San Joaquin County a farm in Escalon had a theft of 140,000 pounds of walnuts; in Wisconsin \$200,000 of Muenster cheese; in Texas rib-eye steaks valued at \$82,000; in Los Angeles 25,000 pounds of king crab worth \$400,000. These are just a few recent news reports of thefts.

With the passage AB 109 (Governor Jerry Brown's so called realignment bill) we see over 500 state crimes have been re-classified as non-prison cases and non-violent, low-level felons are being released to Sacramento County jails and other counties or rehabilitation programs instead of these people remaining in prison.

Crime now appears to be on the rise in the Sacramento area, according to latest FBI statistics and other law enforcement personal except for homicides. The Sacramento Police Department saw its largest spikes in car thefts and assaults, while assaults and rapes showed the biggest increases within the sheriff's jurisdiction.

We can help fight local crime by simply knowing our neighbors and reporting any suspicious activity in our neighborhoods or workplace. The Sheriff or city police can help set up Neighborhood Watch programs.

California and America is rapidly changing—and not always for the better.
